Articles of Association Enforcement Bylaws No. 2 (Rules on Membership Fees) (Englishtranslation Version)

(Application)

Article 1. These Rules stipulate the matters with regard to membership fees for the Japan Society of Clinical Oncology, a general incorporated association (hereinafter, the "Association"), in addition to the matters with regard to Article 9 of these Articles of Association, as follows.

(Fees)

Article 2. Membership fees for regular members of the Association shall be as follows:

(1) Regular members: 12,000 yen per year

(2) Delegates: 15,000 yen per year

2. Annual fees for supporting members of the Association shall be 50,000 yen or more per account.

(Payment rules)

Article 3. Annual membership fees shall be paid in full during the current fiscal year.

2. Annual membership fees cannot be paid in fractional amounts.

(Treatment for fee non-payment)

Article 4. If a member has failed to pay any fees for the preceding fiscal year, he or she shall not be able to view the online Journals from the Association until the membership fees in arrears are paid in full.

2. If a regular member has failed to pay fees for both the preceding and current fiscal year, the Association may cancel his or her eligibility for membership pursuant to the provision of Article 10 of these Articles of Association, as follows.

(1) After reporting to the first Board of Directors meeting to be held following the end of the current fiscal year, the Association shall notify such member by one (1) week before the date of the next meeting of the General Assembly when the cancellation of eligibility for membership is scheduled to be resolved.

(2) The Association shall cancel the member's eligibility for membership based on a

resolution by the General Assembly, except in cases where fees in arrears are paid in full after the measures taken in the preceding paragraph, or when such member provides an explanation in writing or in person at the meeting of the General Assembly, and such explanation is determined to be appropriate.

(3) If a person who has lost his or her eligibility for membership under the preceding item seeks reinstatement, the Association may approve that person's reinstatement as a regular member if the lost eligibility has been for one (1) year or less and the membership fees in arrears and membership fees incurred during the period of loss of eligibility are paid. Such person shall be deemed to have remained a member during the period of loss of eligibility for membership, up to the present. In this case, such person shall undertake admission procedures pursuant to the provision of Article 3 of Detailed Enforcement Regulations No. 1 (Admission Rules) of these Articles of Association.

(Amendment to these Rules)

Article 5. These Rules may be amended in accordance with a resolution by the Board of Directors and the General Assembly.

Supplementary Provisions

- 1. These Rules shall be effective as of January 5, 2009.
- 2. These Rules shall be effective as of October 23, 2013.
- 3. These Rules shall be effective as of October 17, 2018.
